

Get to know your candidates, get to know your constituents event

Objectives

- Bringing citizens and politics closer together in the public space. 200 passers-by are informed about the project, the funding, and the upcoming European elections.
- The aim of the event is to connect 30 citizens and 4+ candidates to the European Parliament from at least 4 parties. We strive to invite one member of each democratic party currently represented in the European Parliament.
- The discussion is moderated
- The exchange can take up to 3 hours
- Connect the results from the Parliament on the Future of Europe final proposals with the elections and commit candidates to taking them up after the elections.
- Mobilize inactive, under-represented and discriminated groups to vote in the EP elections, continue to participate democratically after the elections, and hence booster their use of European citizens' rights.
- Support these groups in prioritizing certain issues/candidates when casting their votes.
- Create awareness for barriers/inaccessibility in the EU's and national electoral processes. Communicate these barriers to citizens and decision-makers so that they can be removed.
- Democracy International evaluates the process and communicate the results to all partners.

Outreach and Promotion

Promotion on social media before, during and after the event is required. Formats include quotes, videos, photos. All partners share relevant content on social media. The funding by the European Commission is always highlighted. Please bear in mind the Social Media Guidelines (page 3) when publicizing the project.

Social Media Diary:

Organizations are required to

- One participant/team member films/photographs various sequences during the day to provide direct insight during the events, i.e. social media diary
- Promotion on social media before, during, and after the event. All partners share news on social media. The funding by the European Commission is always highlighted.
- 1 month after the Citizens' Panel, the first version of the Feedback Catalogue on the Panel topic is published online by DI. All partners promote the final version in their networks. They also send it to previous and future Panel-participants in their country.

- When posting, partners should tag Democracy International and other partners



ANNEXURE B – CHILD PROTECTION POLICY



CHILD PROTECTION POLICY

For all participants under the age of 18 in the transnational citizens' panels and the local "get to know your candidate, get to know your constituent" events of the *Parliament for the Future of Europe* project, the following guidelines apply:

Participation

- Participants under the of 18 must have a letter of consent signed by their parent or legal guardian to be eligible to participate.
- Permission must be granted for the use of their picture, audio, likeness by the parent/legal guardian.
- Respect for their human rights and dignity should be protected during their participation with special regard to their consent.

Travel

- The inviting partner must designate a specific person to chaperone said participants from their place of residence and back.
- The chaperone must be fit and proper to take on such responsibility.

Accommodation

- Underage participants must be housed in facilities safe and proper with precaution taken.

Exposure to Risk

- The inviting partner must endeavor to limit the exposure of the participants to inappropriate content, substances, and activities that will endanger the health and wellbeing of said participants whilst under their care.
- When an incident occurs, the designated person must inform the parent/legal guardian of the participant and take relevant action, including medical, legal etc.
